Location

The property is located in a prominent position on the A62 Oldham Road, close to its junction with Dean Lane, in the Newton Heath district, approximately 2.5 miles from Manchester city centre, and 4 miles south west of Oldham town centre. There are new residential developments to the side and rear accessed via Dixon Street and Oldham Road.

Description

A former bank premises which is arranged over ground floor, with additional basement storage. The property could suit a number of business uses, and would particularly suit retail or office use. There is on street parking to the side.

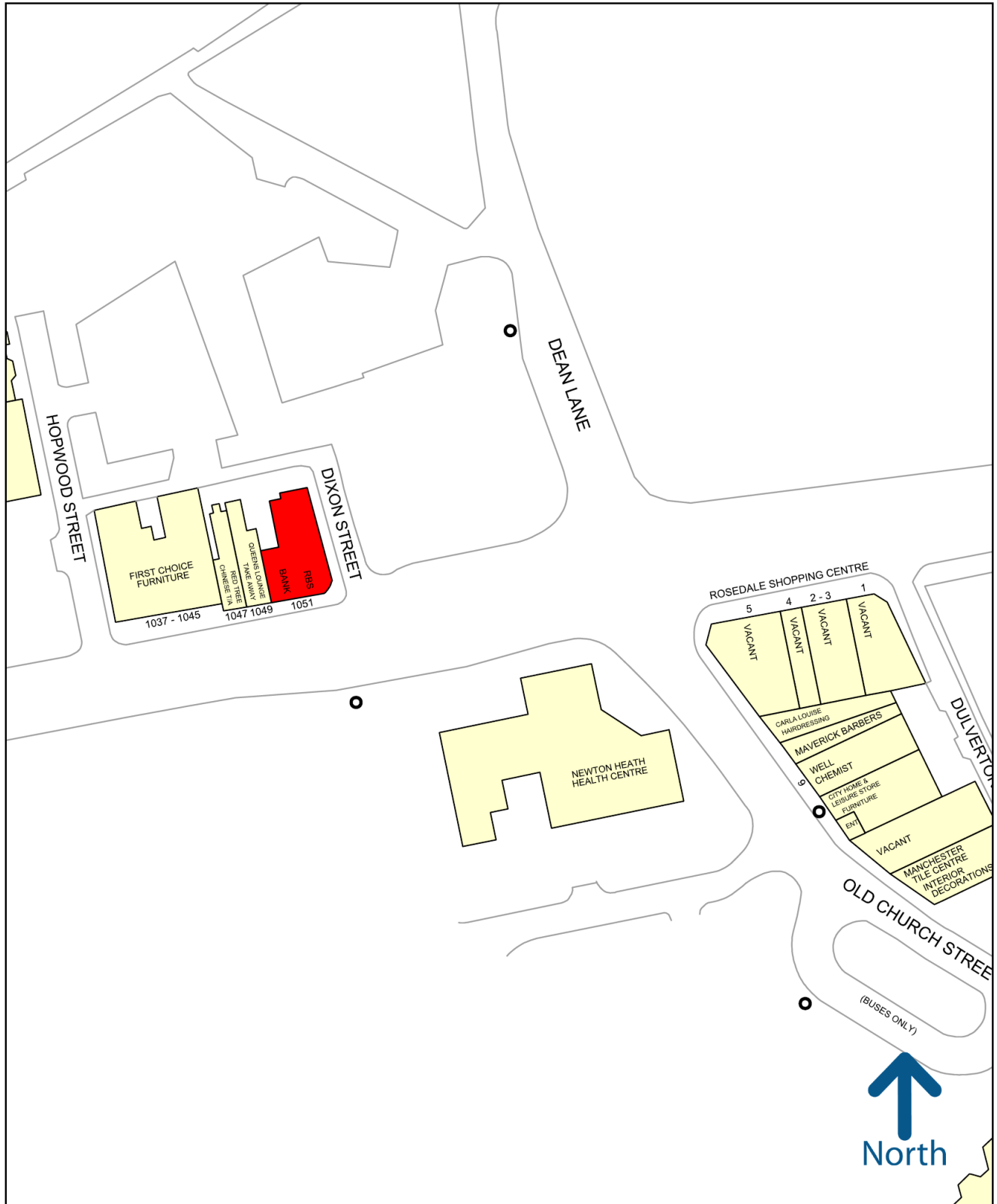
