### **LOCATION**

The property is situated in Ty Verlon Industrial Estate, Barry (CF63 2BG), an established industrial location situated to the South East of Barry, approximately 6 miles south west of Cardiff City Centre. Junction 33 of the M4 Motorway is approximately 8 miles to the north and is accessed via the A4050 and A4232 dual carriageway road.

The area benefits from public transport links, with a regular bus service passing through Cardiff Road and a commuter railway station within a short walking distance. Local occupiers include, Mason Storage, Screwfix, Eriks and Edmundson Electrical. In close proximity to the estate are a Waitrose Supermarket and McDonalds Drive Thru.
