Situation

The Dunston Industrial Estate lies immediately to the east of the MetroCentre and within only ½ mile of the A1 Western Bypass. Both Newcastle and Gateshead Centres lie approximately 3 miles to the east of the site.

Description

The unit forms part of a development of 11 warehouse/industrial buildings built in 2005. The building is of steel portal framed construction with cavity brickwork and insulated profile steel cladding to the external walls and an insulated profile steel sheeted roof incorporating double skin translucent roof lights.

Internally the unit has a reinforced concrete floor to the ground floor level and an internal clear height of 6 metres. Constructed within the unit are two single storey office areas one of which incorporates ladies & gents WC facilities along with a kitchen area, over which is a mezzanine storage area. The accommodation is of demountable construction and therefore can be easily removed if not required.

Externally there is a large shared service area along with 8 dedicated car parking spaces. Vehicular access is gained by way of an insulated sectional loading door 3.6m wide by 4.2m high.

Services

The unit is provided with mains supplies of water, gas and 3 phase electricity. Lighting to the workshop area is by way of low bay halogen units and to the offices by way of fluorescent strips.

Heating to the office and ancillary block is by way of a gas fired combi boiler serving panel radiators.

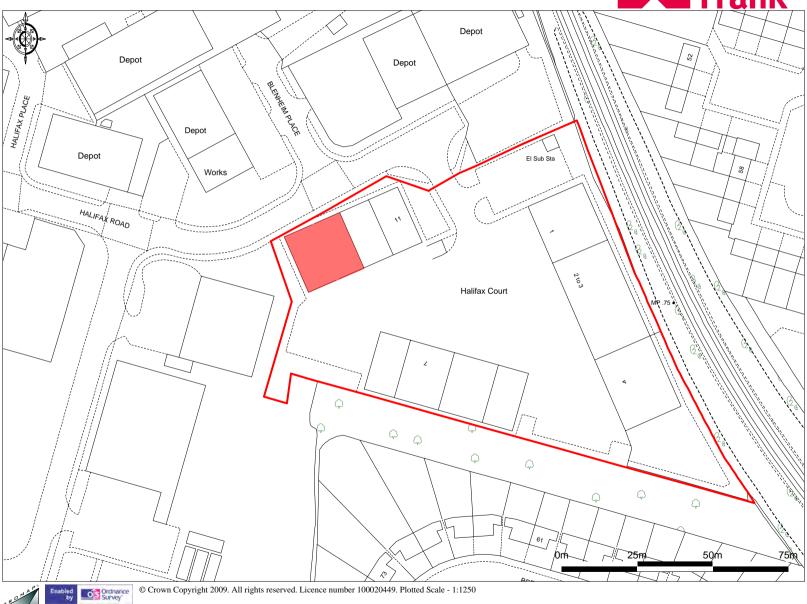
