Location

The property is situated on Clough road which is located on the western side of Rotherham city centre. The property is accessed from New Wortley Road, which provides access to Meadow Bank Road to the north affording easy access to the M1 via Junction 34.

The surrounding area is predominantly mixed use, benefitting from a number of commercial occupiers surrounding the site.

Description

The accommodation comprises of a detached industrial property of steel portal framed construction, set beneath a pitched roof with transparent roof lights.

The warehouse accommodation is largely open plan with concrete flooring and has been fitted with fluorescent strip lighting, a gas fired heat blower and connections to all mains services. The property benefits from an eaves height of 4.1m.

The property benefits from having a small amount of office accommodation within the warehouse, benefitting from a specification to include painted plaster walls and fluorescent strip lighting. There is also a toilet and kitchenette in situ.

Loading facilities are provided through a full height loading door.
