Location

New Quay is a seaside town in Ceredigion, West Wales with a resident population of around 1,200 people. Located on Cardigan Bay with a harbour and large sandy beaches, it is a popular seaside resort and traditional fishing town. The property is located on South John Street fronting the main seaside parade in New Quay with nearby occupiers being a mixture of local restaurants, pubs, shops and residential.

Description

The property comprises a semi-detached end of row retail unit built over ground, basement & first floor. It is constructed of stone construction with a pitched tiled roof. There is a steeply sloping garden to the rear with separate access from the rear lane known as High Terrace.

Internally the unit is made up of a mix of banking hall with ancillary offices and stores accommodation.

Tenure

The subject property is available to purchase on a freehold basis with full vacant possession.

The property has a historic use as a Bank & Premises.
