

LOCATION

Ayr is the principal settlement in South Ayrshire with a resident population of around 46,800 and has a lively historic town centre environment in which to conduct business.

Located on Wellington Square, a popular and established town centre office location, the Business Centre provides a variety of suites of different character, layout and size – fully refurbished. On-street car parking is available on Wellington Square. There are a range of coffee shops and restaurants within close proximity.

Wellington Square Business Centre is already home to a variety of local businesses.

THE PROPERTY

Wellington Square Business Centre provides attractive workspace over four levels in twelve self-contained business units. The common stairwell and entrance hall have been completely refurbished including new décor, new carpeting and new lighting creating a bright, contemporary feel.

The Centre provides common male, female and disabled toilet facilities. An external courtyard area provides seating for the tenants to utilise.

The premises offer a unique working environment suitable for a range of business functions. The majority of suites have attractive views either over the Square or the Ayrshire Coastline.

Access is directly from Wellington Square and via a security door entry system. Storm doors are closed at night but as each tenant has their own keys, 24 hour access is available.

Each tenant is afforded signage directly onto the Square on external directory signs.

There are break out areas for informal meetings around the Centre for communal use.

RATING ASSESSMENT


Rents are quoted exclusive of rates, VAT and electricity consumption and tenants are responsible for these costs. Rents are quoted inclusive of all other building services.


The energy performance of all offices is rated 'D'.




