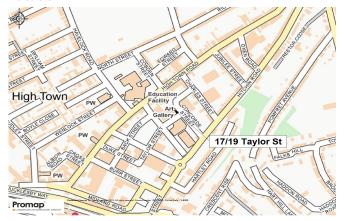

Location



The property is situated on Taylor Street which is located to the north-east of Luton town centre and Junction 10 of the M1 motorway. Luton mainline railway station is approximately 0.3 miles away and offers train services to Central London, Bedford and Gatwick Airport.

The property is located in an area of mixed uses including residential, industrial and trade counters.

Much of the local area surrounding High Town has been subject to regeneration.

The property comprises of a detached brick built warehouse with two storey offices constructed in the 1970's and benefits from the following specification:

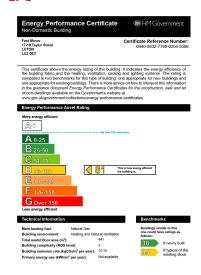
