Location

Alsager is a town located in the south-east of Cheshire, situated approximately 10 miles north-west of Stoke-on-Trent and 6 miles east of Crewe. The land is situated just off the B5077 trunk road and is positioned to the side and to the rear of The Plough public house. The immediate surrounding area is a mixture of residential dwellings and open farm land. Amenities within the wider surroundings include schools, restaurants/cafes and retailers.

Description

The land is a mixture of woodland and grassland amounting to circa 5 acres. We understand that the land is excluded from both the Green belt and local Conservation Areas. The borders of the land are dominated by mature trees and shrubbery, with a river running along the southern border. The land is currently only accessible via the public houses car park.

The land presents an opportunity for local farmers / animal owners who are in need of grazing land.




