#### Location

The property is located within Orchard Park Industrial Estate, a well-established industrial and commercial business location. The estate is located less than 0.5 miles from Sandiacre town centre accessible via Town Street.

Sandiacre lies to the west of Nottingham lying in close proximity to the border with Derbyshire and within Erewash Borough Council. The estate is located in close proximity to Junction 25 of the M1 motorway and also has access to the A52 which links Nottingham to Derby. Nottingham city centre is approximately 6 miles due east and Derby city centre lies approximately 8 miles due west.

#### **Description**

The property comprises a hybrid unit configured to provide warehouse/storage accommodation at ground floor with office space at first floor. The unit benefits from air conditioning and gas warm air heating. Externally there is allocated parking with a yard to the side elevation.


