### Situation

The business trades from a prominently positioned location on the busy Battlefields Trading Estate. The surrounding premises include a mix of commercial/trade counter and office properties with occupiers including Volkswagon and Mercedes Car Dealerships, and Travis Perkins.

Battlefield Enterprise Park is in a popular and fast expanding commercial and retail, industrial and office location situated approximately 3 miles north of Shrewsbury.

Shrewsbury is the County Town of Shropshire and is an established administrative and tourist centre with a population of 100,000.

### Description

The business operates from a very modern 'trade counter' industrial unit on the outskirts of a major West Midlands town.

This offers a Total Gross Internal Floor Area of approximately 190m sq of space. The accommodation is arranged over 2 floors, an office (16m sq), as well as a fully fitted showroom (51m sq) that allows the business to display the latest range of hot tubs, pool equipment, chemicals and toys.

Established for over 13 years it enjoys a strong reputation for the quality of the service and products provided. It is the sole supplier for two major brands in this county and beyond.

#### **Business**

The business is run by a husband and wife. With 2 part time staff.

The owners are responsible for the sales, the technical details and management of installations and maintenance. They both work full time (more during the summer, but less during the winter). Technically one of them is a fully qualified Swimming Pool Engineer, but they only got this qualification after they bought the business, having come from a completely different industry.

They employ 1 technician to assist with all sites, working an average of 4-5 days per week, but on a seasonal basis.

Additionally there is a Business Administrator to assist in the office working 4 days a week.

Other trades are sourced on a sub-contract basis as required.

The majority of sales (around 80%) are from installation and refurbishment of swimming pools, both indoor and outdoor, for private customers. These are mainly gained from recommendation by satisfied customers, with others coming from architects and builders.


