



LOCATION

Hertford is a historic county town situated approximately 19 miles north of Central London and provides an attractive shopping, working and recreational environment.

The properties are situated within Foxholes Business Park adjoining the A414 and a short distance from the A10 Great Cambridge Road.

The A414 provides access to the A1M at Hatfield and the M11 at Harlow with the M25 being approximately 8 miles to the south. Hertford is convenient to both Luton and Stansted Airports. Rail connections are provided by Hertford East Station with services to London Liverpool Street and Hertford North Station providing services to Moorgate with underground interchange at Finsbury Park (Victoria/Piccadilly Lines).
