LOCATION

The site is located immediately to the east of Melton Mowbray town centre with frontage and access to the A607 Thorpe Road.

Melton Mowbray is approximately 20 miles from Leicester and Nottingham, with the train station on the Birmingham to Peterborough line about 5 minutes from the site.

DESCRIPTION

The site is surrounded by predominantly residential development with some retail and town centre uses. Immediately to the rear of the site is the Melton Mowbray hospital.

The site contains a range of former hospital buildings including a number on the Council's Historic Buildings Register. The planning application submitted to the Council proposes the removal of the majority of these buildings with the exception of the central block of the former workhouse.

A pedestrian access to the new hospital is at the north end of the site, and will be retained in any development. The new access road to serve the development will also be available for hospital use.


PLANNING

Planning application reference number 19/00909/OUT has been lodged with Melton Borough Council for:

"Change of use of the central block of the former workhouse building to comprise 4 residential apartments with associated parking and amenity space. Outline application for demolition of existing buildings and structures on site and redevelopment of the site for up to 44 new dwellings together with associated access and site infrastructure. All matters are reserved except access "

Full details of the planning application and the submitted documents are contained within the data room, and it is intended that the site will be sold with the benefit of an outline planning permission, conditional only upon receipt of reserved matters approval within a specified timeframe.


