Quay Point is situated within Ocean Park, an established business and commercial location to the South of Cardiff City Centre, and is accessed via Ocean Way.

DESCRIPTION

This mid terrace unit is of steel portal frame construction with lower elevetions of brickwork and the upper elevations and pitched roof of steel profiled steel cladding.

Internally the unit is split into warehouse space and office accommodation with a separate kitchen and two WC's on the ground floor. The minimum height is 6.5. The warehouse has a level access door to the parking area and an electric roller shutter door for loading.

The first floor has the addition of a mezzanine level that includes further storage/office space.
