

Location

The subjects are located within the village of Maybole which lies in the South Ayrshire Council area, approximately 7 miles south of Ayr on the A77. The town has a resident population of around 4,500.

The property is situated on Kirkoswald Road, at the south most end of the village adjacent to Carrick Academy. The site is positioned in a mainly residential area and is within easy walking distance of all main amenities, including schools, shops, a local golf course and a swimming pool.



Description

The subjects comprise a large brick built workshop and offices formed over one and two storeys having a gross internal floor area of 967.3 m² (10,412 ft²). The premises benefit from a substantial yard area with an extensive road frontage.

Planning

The property is located in an area zoned for residential use within the South Ayrshire Local Plan. Outline planning consent for private retirement sheltered housing was granted in 2008 although this has now lapsed.

The property therefore offers potential for development for residential or possibly commercial use subject to local authority consents. All enquiries regarding planning should be made to South Ayrshire Council Planning Department.
