Location

The subject branch is located in Uplands which is approximately 1.5 miles west of Swansea city centre. The area is a mixed demographic residential area with the areas along Uplands Crescent providing retail and food led provision. Nearby occupiers include the Post office, Sainsbury's Local, Tesco Metro and a number of takeaway and restaurant occupiers.

Description

The property comprises a three storey mid terraced building of solid brick and stone elevations under a pitched slate roof. Internally, the ground floor is fitted out as a banking hall. The upper floors comprise staff and ancillary areas over the remaining 2 levels. Upper floors are all in a poorer condition and in need of refurbishment.

The rear area could provide a separate access to upper floors in the instance of any residential conversion.

The property has an historic use as a Bank & Premises.
