Location

Broughty Ferry is a popular suburb of Dundee, located on the north bank of the Tay Estuary approximately 4 miles east of Dundee city centre. It has a population of approximately 17,500 and is one of the most affluent and sought after areas of the city.

The property is located in central Broughty Ferry within Gray Street, to the south of its junction with Brook Street.

Description

The subjects comprise a ground round retail premises within a traditional three storey stone building under a pitched and slated roof.

Internally, the premises are arranged to provide a front shop with kitchenette and WC to the rear.

The premises benefit from a large single glazed timber framed window frontage to Gray Street, a recessed timber and glazed doorway, laminate finish to the floor, plasterboard lined walls and ceilings with inset spotlighting, and a CCTV and indruder alarm system. The shop is fitted to an excellent standard.
