Location

Annan is a town in the council area of Dumfries & Galloway having an approximate resident population of 8,500.

Annan is accessed via the A75 which runs from its connection with the A74 motorway by Gretna Green in the east, to its most westerly point in Stranraer, via the administrative centre of the region, Dumfries, which lies 16 miles north west of Annan.

The subject property occupies a prominent position on Butts Street, just to the north of the High Street (B721) and in close proximity to Annan's bus station.

Description

The subject property comprises a stand alone retail unit which has planning permission for subdivision. The property is arranged with sales on ground floor and staff and storage space on the first floor. There is a shared car park.


