## Location

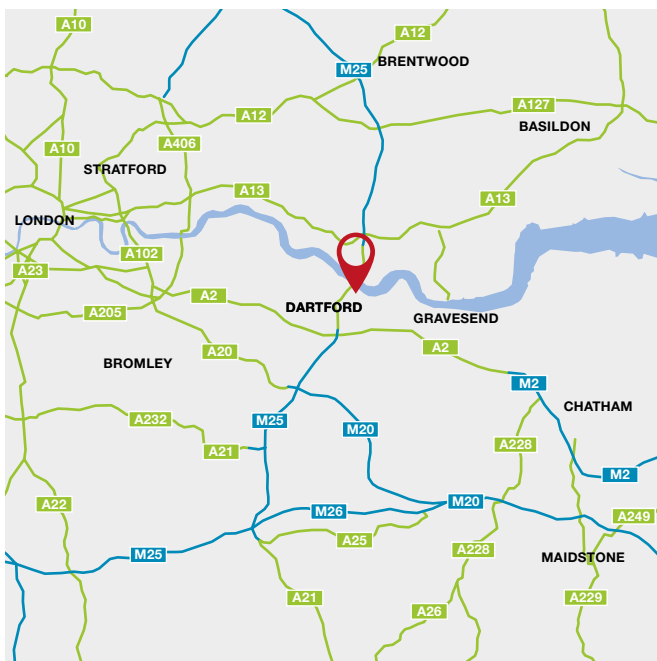
