# 0.66 Acres & Associated Buildings

#### Location

The property is located at Aston close to Junction 31 of the M1 Motorway. The site is ideally located being 30m from Junction 31 of the M1 motorway with access to the site via Worksop Road. The proximity and prominence to the main road and motorway links provide a potential alternative site use subject to obtaining the necessary planning consents.

The site is approximately 6km from both Sheffield and Rotherham Town Centres with Dinnington approximately 2 miles east of the location. The surrounding land uses include a mix of both commercial and residential land uses with the adjoining users along Worksop Road being residential.

# Description

The property comprises a converted former residential dwelling currently used for as head offices for MVS and associated warehouse/storage buildings and yard.

Currently the site holds an MOT testing station for class (4) and (7) commercial vehicles.

Externally the site is majority hardstanding and secured by a perimeter fence.

From measurements provided the site measures approximately 0.66 acres.

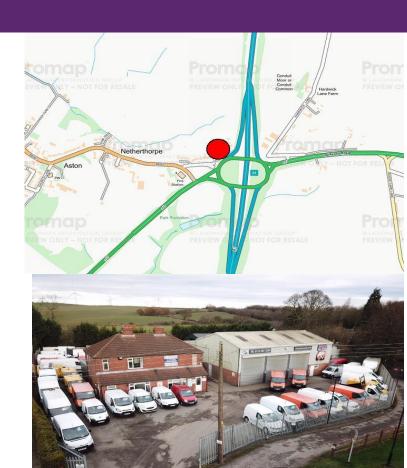
