LOCATION

The site is located on the southern side of the A13 at the Lodge Avenue Roundabout, and therefore benefits from east and west-bound access.

The A13 provides direct link to the M25 (j30/31) to the east and the A406 and City to the West. Underground links are provided at Upney station (District line) which is a short distance north west of the site.

The immediate area is very popular with trade counter operators, with Screwfix, Minster, Edmundson Electrical, Dulux, Leyland Trade, Plumbase all within the vicinity.

DESCRIPTION

The site is generally rectangular in shape and hard surfaced extending to approximately 1.55 acres.

The site houses an existing industrial building over ground and lower ground floors. Further single storey light industrial buildings have been added, and the overall accommodation extends to approximately 35,400 sq. ft.


PLANNING


