#### Location

Swaffham is a busy traditional market town approximately 30 miles west of the regional centre of Norwich and lying between King's Lynn (20 miles) and Dereham (15 miles) immediately to the south of the main A47 trunk road and the A1065 Fakenham to Barton Mills Road with access to the A11/M11. Traders represented in Swaffham include numerous local independent outlets along with national retailers including McCalls, Boots and Waitrose.

Occupiers on the Ecotech Business Park include Waitrose, doctors surgery, private school, care home, and an extensive range of firms and businesses.

The property is located on the Ecotech Business Park which is home to the Green Britain Centre, part of the Green Britain Foundation, which has the only wind turbine in the world open to the public to climb. The centre offers several sizes of conferencing facilities, café and catering facilities for the meeting rooms.

#### Description

The property comprises a terrace of three business units with ground floor workspaces and first floor offices which provide well service and attractive accommodation.

Externally, there is parking to the front and service doors to the rear along with further parking.
