Location

The warehouse is regular shaped with a concrete floor, gas blow heating, an internal eaves height of around 5.70m (18' 8"") and drive-in loading being provided to both the front and rear via motorised roller shutter doors.

The offices typically have fluorescent lighting, suspended ceilings (first floor), central heating and carpet covered floors.

Externally, there is a forecourt providing loading access to the front and parking for around 7/8 cars, whilst loading access to the rear is via a shared access.
